

Tribal PFAS Working Group: A Look Back at 2024

Throughout 2024, the <u>Tribal PFAS Working Group</u> continued to provide outreach and learn more about PFAS contamination and potential treatment or remediation. The following highlights the activities conducted in 2024.

Outreach and Education

The working group held a one-day workshop titled "PFAS 101" at the ITEP Tribal Lands and Environment Forum on August 12, 2024, in Eugene, Oregon. The workshop included presentations on the EPA PFAS Roadmap, tribal-specific concerns, PFAS and air, and mapping of PFAS on tribal lands. NEW! Understanding the EPA's New Regulatory Revisions to Water Quality Standards for Protecting Tribal Reserved Rights Rule -- Two-Part Webinar Series

The National Congress of American Indians (NCAI), in partnership with the National Tribal Water Council (NTWC), National Association of Wetland Managers (NAWM), and the American Bar Association Section of Environment, Energy, and Resources (ABA SEER), invites Tribal Nations, state environmental agencies, and the public to a two-part webinar series hosted by NCAI's Institute for Environmental Sovereignty (IES). The series will focus on the U.S. EPA's newly finalized Tribal Reserved Rights Rule, which revises 40 CFR Part 131 to require the EPA and states to consider Tribal reserved rights—such as fishing, hunting, and gathering—when establishing or revising water quality standards.

- Part 1 Thursday, January 23, 2025, at 3:00 PM EST
 - Focuses on the rule's key components and Tribal-State collaboration, featuring insights from an EPA representative and the Fond du Lac Band's Water Projects Coordinator.
- Part 2 Thursday, January 30, 2025, at 3:00 PM EST
 Explores state implementation challenges and opportunities, with speakers—including state agency representatives and the Native American Rights Fund (NARF)—discussing legal considerations and fostering collaboration.

EPA Releases a Tribal Water & Natural Resources Conservation Guide

EPA released a <u>Tribal Water & Natural Resources Conservation Guide</u> for tribal environmental program managers and staff. This guide aims to provide resources to tribal environmental programs about federal assistance opportunities that can support tribally led efforts to protect and restore waters, protect air quality, protect wildlife and habitat, prepare for climate change and natural hazards, steward lands, and support and engage tribal communities. This comprehensive resource guide includes:

- An introduction to federal assistance for new tribal staff,
- Quick reference tables highlighting tribal-specific funding and technical assistance programs,
- 10+ tribal case studies highlighting how tribal programs have completed conservation projects with federal assistance, and
- Examples of federal planning frameworks and tools.

The EPA also published a <u>federal funding program inventory</u> as a supplement to the guide, available as a downloadable Excel Workbook that contains basic information about 150+ federal funding programs that can support tribal conservation work.

TRIBAL CONSULTATION OPPORTUNITIES

EPA Issues Advance Notice of Proposed Rulemaking to Protect Salmon from Chemical Used in Rubber Products

Deadline: January 21, 2025

The EPA is issuing an advance notice of proposed rulemaking (ANPRM) under Section 6 of the Toxic Substances Control Act to gather information on the potential risks associated with N-(1,3-Dimethylbutyl)-N'-phenyl-p-phenylenediamine (6PPD) and its transformation product, 6PPD-quinone, a substance often found in tire-rubber particles. In August 2023, the Yurok Tribe, the Port Gamble S'Klallam Tribe and the Puyallup Tribe of Indians submitted a petition under TSCA Section 21 asking EPA to establish regulations under TSCA Section 6 prohibiting the manufacturing, processing, use and distribution of 6PPD in tires. The EPA granted this petition in November 2023 and committed to publishing an ANPRM by Fall 2024 in order to gather more information that could be used to inform a subsequent regulatory action. The EPA will accept written comments on the ANPRM for 60 days following publication via the docket at Regulations.gov.

EPA's Proposed National Primary Drinking Water Regulation for Perchlorate

Deadline: February 28, 2025

The EPA is initiating consultation and coordination on the forthcoming proposed rulemaking, the National Primary Drinking Water Regulation for Perchlorate, as required by recent court orders. The EPA is developing the proposed regulation to improve public health protection by reducing perchlorate exposure from drinking water. The proposed rule would impact owners and operators of public water systems subject to the rule requirements as defined by the Safe Drinking Water Act, along with primacy agencies that enforce drinking water regulations in their jurisdiction. There are approximately 1,000 Tribal public water systems and the Navajo Nation has primacy for over 170 public water systems. EPA's Draft National Recommended Water Quality Criteria for the Protection of Human Health for PFOA, PFOS, and PFBS

Deadline: February 24, 2025

The EPA has released draft national recommended health-based levels (human health criteria) for three per- and polyfluoroalkyl substances (PFAS) in water bodies. The three PFAS are perfluorooctanoic acid (PFOA), perfluorooctane sulfonic acid (PFOS), and perfluorobutane sulfonic acid (PFBS). Human health criteria are not legally enforceable, rather they are information for local entities to consider when making local decisions about water quality.

The EPA will accept written comments on the draft human health criteria until February 24, 2025. Section 304(a) of the Clean Water Act (CWA) directs the EPA to develop and publish water quality criteria that accurately reflect the latest scientific knowledge about the effects of particular pollutants on human health and welfare. The EPA's CWA Section 304(a) human health criteria are recommendations to states and Tribes authorized to establish their own water quality standards under the CWA. Once final, these recommended criteria can be used by states and authorized Tribes to develop their own water quality criteria that help protect people from exposure through consuming water, fish and shellfish from inland and nearshore water bodies that may be contaminated by any of these PFAS. EPA's Proposed Update to the Office of Civil Enforcement's 2007 *Questions and Answers* on the Tribal Enforcement Process

Deadline: March 3, 2025

The EPA is initiating consultation with federally recognized Tribes on a proposed update to the Office of Civil Enforcement's 2007 *Questions and Answers on the Tribal Enforcement Process* ("Questions and Answers"). The Questions and Answers document implements the Office of Enforcement and Compliance Assurance's *Guidance on the Enforcement Principles Outlined in the 1984 Indian Policy* to ensure compliance at federally-regulated facilities in Indian country.

EPA Released Three Draft Chapters of the Water Quality Standard Handbook on Designated Uses, Antidegradation, and WQS Variances

Deadline: March 12, 2025

On December 12, 2024, the EPA released three draft chapters of the WQS Handbook on Designated Uses, Antidegradation, and WQS Variances for a 90-day public comment period. The WQS Handbook provides a plain language discussion of the relevant regulatory and statutory requirements and the EPA's recommendations for how states, authorized Tribes and U.S. territories can develop and implement WQS consistent with both. The EPA has updated Chapter 2 on Designated Uses, Chapter 4 on Antidegradation, and developed a new chapter on WQS Variances to include the EPA's most recent WQS programmatic policy and guidance to implement the regulation at 40 CFR Part 131.

The EPA is holding three informational webinars during the public comment period to provide an overview of the chapters and an opportunity for participants to ask clarifying questions after having read the chapters. Each webinar will cover the same material.

NTWC WHITE PAPER

NEW! National Tribal Water Council's White Paper on the John M. Asplund Water Pollution Control Facility CWA Section 301(h) Waiver of Secondary Treatment for NPDES Permit Renewal

The National Tribal Water Council produced a white paper regarding the concerns about the Clean Water Act (CWA) Section 301(h) Waiver of the Asplund Water Pollution Control Facility (WPCF) in Anchorage, Alaska. The NTWC undertook extensive research into EPA's CWA Section 301(h) Waiver to understand the issues and implications of the waiver provided to the Asplund WPCF. The NTWC is convinced that this waiver has far-reaching negative consequences by not renewing the permit according to a 5-year renewal cycle. Further, the NTWC has significant concerns about the inadequate environmental and human health protections in the Cook Inlet area. The white paper includes a list of recommendations for the US EPA and other appropriate agencies to address the issues associated with the Asplund WPCF.
