


Highlight of the Tribal PFAS Working Group's Summer Webinar "Model Predicts PFAS Buildup in Wild Animals"

On June 12, 2025, the Tribal PFAS Working Group hosted a webinar titled "Model Predicts PFAS Buildup in Wild Animals," by Dr. Elsie Sunderland, Fred Kavli Professor of Environmental Chemistry and Professor of Earth and Planetary Sciences, Harvard University. Dr. Sunderland presented their research to develop a model that predicts how PFAS moves and builds up within food webs.

Dr. Sunderland started the webinar by providing an overview of PFAS and how it's measured using analytical methods. The model considers features of different animals, such as their size, feeding rate, metabolism, excretion, and the complex interactions between animals that make up different food webs. A few examples were provided, including examining the Canadian arctic marine food web and biosolids contamination on farms in Maine.

EPA Pacific Northwest Tribal Clean Water Act Training, November 17-20, 2025

The training will address Clean Water Act (CWA) programs including Section 106, Section 319, Section 303(d), water quality standards, and wetlands and will be useful to Tribes who work on these programs or are interested in pursuing Treatment in a similar manner as a State (TAS) status for one or more programs. The training workshop is targeted to Tribes who conduct water quality monitoring, issue water quality certifications, and address water quality issues, nonpoint source pollution, and impaired waters/TMDLs. Tribal staff from across the country are invited, although there will be a focus on examples and applications for Tribes in the Pacific Northwest.

The National Tribal Water Council is a technical and scientific body established to advocate for the best interests of federally-recognized Indian and Alaska Native Tribes in matters pertaining to water quality.

WHAT WE DO

- Policy Response: Conducts analysis of water polices and initiatives that impact Tribes and responds by preparing comment letters, white papers, or briefs.
- Information Exchange: Engage and collaborate with national, regional, tribal organizations, or working groups.
- Set Priorities: Publish a biennial "Tribal Water Priorities" document that identifies Clean Water Act (CWA) and Safe Drinking Water Act (SDWA) priorities.

OPEN POSITIONS: AT-LARGE REPRESENTATIVE

The Council is accepting applications from tribal water professionals employed by a federally recognized Tribe or tribally authorized organization from Regions 1 to 10 to fill two (2) vacancies for the At-Large positions.

Tribal water professionals with knowledge in the CWA and SDWA are encouraged to apply. Also, an applicant with a background in water infrastructure, drinking water, wastewater, and operations and maintenance, is a plus but not required.

TRIBAL CONSULTATION OPPORTUNITIES

U.S. Army Corp of Engineer's Proposal to Renew and Revise Nationwide Permits Deadline: July 18, 2025

The U.S. Army Corps of Engineers (USACE) is seeking comments on its proposal to renew and revise 56 existing nationwide permits and issue one new nationwide permit authorizing activities associated with improving fish passage. Nationwide permits authorize activities in wetlands and other waters that are regulated by Section 404 of the Clean Water Act and/or Section 10 of the Rivers and Harbors Act of 1899.

Key highlights:

- Proposes phasing out the permit for finfish mariculture.
- Introduces one new nationwide permit aimed at improving fish passage infrastructure.
- Permits cover a range of activities—from utility installation and navigation aids to streambank stabilization and residential projects—designed to have minimal environmental impact individually and cumulatively.
- Current permits will expire March 14, 2026, so the Corps is targeting final approval of updates before then.

USACE division engineers may add, after public review and consultation, regional conditions to nationwide permits to protect local aquatic ecosystems, such as fens or bottomland hardwoods or to minimize adverse effects on fish or shellfish spawning, wildlife nesting or other ecologically critical areas. A public notice soliciting comments on the proposed set of revised nationwide permits was published in the June 18, 2025, Federal Register at https://www.federalregister.gov/documents/2025/06/18/2025-11190/proposal-to-reissue-and-modify-nationwide-permits. USACE will accept written comments through July 18, 2025. EPA's Draft Sewage Sludge Risk Assessment for PFOA and PFOS

Extended Deadline: August 15, 2025

The EPA released the Draft Sewage Sludge Risk Assessment for Perfluorooctanoic Acid (PFOA) and Perfluorooctane Sulfonic Acid (PFOS) for public comment. The draft risk assessment reflects the agency's latest scientific understanding of the potential risks to human health and the environment posed by the presence of <u>PFOA and PFOS in sewage sludge</u> that is land applied as a soil conditioner or fertilizer (on agricultural, forested, and other lands), surface disposed (e.g., placed in a sewage sludge-only landfill called a monofill), or incinerated.

EPA's Proposed renewal of the NPDES Stormwater Construction General Permit Deadline: September 5, 2025

The EPA is initiating consultation and coordination with federally recognized Indian Tribes on the proposed renewal of the National Pollutant Discharge Elimination System (NPDES) Stormwater Construction General Permit (CGP). Under Clean Water Act section 402(p)(2) and (p)(6) and 40 CFR 122.26(a)(1)(ii), (a)(9)(i)(B) (b)(14)(x), and (b)(15), stormwater discharges from certain construction activities into waters of the United States must be authorized by a state or EPA-issued NPDES permit.

The CGP regulates stormwater discharges from construction activities (including, but not limited to, clearing,

grading, excavating, and stockpiling) that disturb one or more acres, or smaller sites that are part of a larger common plan of development or sale that disturb one or more acres in areas where EPA is the permitting authority. EPA renews this permit every five years, and the current CGP is scheduled to expire on February 17, 2027. EPA is the NPDES permitting authority in most Indian Country lands. EPA's Upcoming Efforts to Address Implementation Challenges Associated with CWA Section 401

Deadline: September 7, 2025

The EPA is initiating consultation with federally recognized Indian Tribes on regulatory uncertainty or implementation challenges associated with Clean Water Act Section 401 certification process as defined in the 2023 Water Quality Certification Improvement Rule. The tribal consultation kick-off webinar is scheduled on July 23, 2025 (2-4 PM ET), to register: Registration Link

Upcoming Listening Sessions and Written Recommendations Docket: Closes August 6, 2025

Separate from the Tribal consultation, on July 1, the agency announced a Federal Register Notice initiating a series of stakeholder listening sessions and a 30-day recommendations docket (Docket ID No. EPA-HQ-OW-2025-0272) inviting written feedback on regulatory uncertainty or implementation challenges associated with the Clean Water Act section 401 certification process as defined in the 2023 Rule.

Public listening sessions:

- July 16, 2025, 1:00 4:30 pm (virtual), Register
- July 30, 2025, 1:00 4:30 pm (virtual), <u>Register</u>

The <u>notice</u> was published on July 7, 2025. The public has 30 days to provide input on regulatory uncertainty and implementation challenges related to the 2023 Rule. The public comment period closes August 6, 2025.

Memorandum on Clarification regarding the Application of Clean Water Act Section 401 Certification: On May 21, 2025, <u>EPA issued a memorandum</u> that clarified the significant but limited role that states and Tribes play in the federal licensing and permitting processes under Clean Water Act Section 401. The direction provided in this memorandum reflects the <u>existing requirements</u> of the agency's CWA section 401 certification rule issued in 2023, without changes or updates.
