### **PM Uncertainty Peer Review Panel**

EPA is developing new techniques to understand, characterize, and communicate the health benefits associated with reducing fine particles (PM<sub>2.5</sub>) at low concentrations in the outdoor air and will be drafting a technical report about these techniques. EPA is convening a panel of independent scientific experts that will review the EPA report. The Agency is soliciting nominations for experts to join this peer review panel. GRITS is a project-management platform used by nearly 800 institutions to calculate, track, and share the energy, financial, and carbon savings data from their sustainability projects. With a broad range of users across sectors, both Portfolio Manager and GRITS are leading tools being used by institutions to better manage their energy

#### **Achieving Results with Energy Efficiency: EPA's new Guidebook for Energy Efficiency Evaluation, Measurement, and Verification**

Today, jurisdictions around the country continue to use proven energy efficiency policies and programs to meet electricity demand, support economic growth, and avoid generation and pollution from power plants. Every U.S. state currently administers some type of demand-side energy efficiency program, while 25 have adopted a statewide energy efficiency resource standard and others require utilities to deliver “all cost-effective energy efficiency.” To ensure this \$6 billion investment is achieving intended levels of energy savings and emissions reductions, states and cities are adopting and refining requirements for evaluating, measuring, and verifying (EM&V) their energy efficiency investments. EPA’s new [Guidebook for Energy Efficiency Evaluation, Measurement, and Verification](#) draws from and builds on decades of state, local, and private-sector experience

quantifying and verifying savings from energy efficiency projects and measures. The EM&V Guidebook is designed to help state, local, and tribal air and energy officials—as well as key stakeholders such as utility energy efficiency implementers—learn about, establish, or refine their EM&V approaches. The EM&V Guidebook can also help air officials understand the basics of EM&V and work with their energy counterparts to capture the air quality and public health benefits of these existing investments. The guidebook is also designed to:

- Describe key EM&V topics, methods, and approaches
- Ensure that customer-funded EE policies and programs are achieving intended results in a cost-effective manner
- Ensure that EM&V is carried out in a well-documented, rigorous, and consistent manner

The EM&V Guidebook may also help jurisdictions who want to collaborate on air and energy goals, evaluate the resulting air and energy impacts, and plan new policies and programs. [Learn more](#) about EM&V for energy efficiency policies and initiatives

#### **June Is National Healthy Homes Month**

[EPA's Indoor Environments Division](#) shares HUD's goal of ensuring healthy homes by maintaining healthy indoor air. The following strategies will help to maintain and improve your home's indoor air quality (IAQ):

- [Source Control](#)—Eliminate pollution sources or reduce emissions. For example, adjust emissions from gas stoves and eliminate sources of mold and moisture.
- [Better Ventilation](#)—Use exhaust fans when cooking or showering.

- [Filters and Air Cleaners](#)—Change the filter in your heating/cooling system, following the manufacturer’s recommendations. Using an air-cleaning device also may be an option.

You can improve your home’s air quality by [using “green” cleaning products](#), [not smoking indoors](#), [testing your home for radon](#) and [upgrading your heating and cooling systems](#) to be cleaner and more energy efficient, among many [other actions](#).
