

NTWC's Comment Letters on EPA Proposed Rulemaking and Revised Tribal Consultation Policy and Treaty Rights Guidance

The National Tribal Water Council (NTWC) developed and submitted comment letters for two separate consultation opportunities: (1) EPA's Revised Tribal Consultation Policy and Treaty Rights Guidance and (2) EPA's Proposed Rule to Establish Federal Baseline Water Quality Standards for Indian Reservation Waters. The NTWC develops comment letters in collaboration with the NTWC's Tribal Advisory Committee.

EPA's Revised Tribal Consultation Policy and Treaty Rights Guidance

The NTWC created and submitted a comment letter on the EPA's Revised Tribal Consultation Policy and Treaty Rights Guidance on July 21, 2023. The EPA Tribal Consultation Policy establishes national guidelines for consultation with tribes. The Treaty Rights Guidance enhances EPA's consultations where tribal treaty rights may be affected. Once finalized, the revisions will replace the 2011 Tribal Consultation Policy and 2016 Treaty Rights Guidance.

Previously in 2021, the Council recommended three core elements for meaningful consultation, and they are (1) early and consistent tribal engagement; (2) face-to-face interactions; and (3) a deep understanding by federal officials of tribal cultures when providing comments for improving the EPA's 2011 Tribal Consultation Policy. The Council expanded upon those recommendations and continued to stress the importance of meaningful tribal consultation and engagement with tribes.

EPA's Proposed Rule to Establish Federal Baseline Water Quality Standards for Indian Reservation Waters

The NTWC developed and submitted a comment letter on the EPA's Proposed Rule to Establish Federal Baseline Water Quality Standards (WQS) on August 1, 2023. The proposed rule would establish federal baseline WQS for waters on Indian reservations that do not have Clean Water Act (CWA) WQS in place. EPA noted that over 80% of Indian reservations currently do not have the foundational protection of CWA WQS in place for their waters.

The following are highlights of the comments provided by the NTWC:

• Supports federal baseline WQS for Indian reservations without CWA protections. Without federal baseline WQS, the protection and improvement of water quality in Indian Country is limited.

Highlight of NTWC Mid-Year Activities (continued)

- Supports federal baseline WQS as a temporary gap-filler to ensure reservation waters are protected until a tribe obtains TAS status and adopt CWA-approved WQS for their waters.
- Recommends that tribal requests for opting out to the Regional Administrators be consistent across the regions.
- Requests the EPA extend the timeframe for tribes to opt-out to 180 days after publication rather than 90 days.
- Supports EPA's proposal to promulgate a cultural and traditional designated use, which will protect the cultural and traditional uses of Indian reservation waters.

FY23-24 Tribal Regional Ocean Partnership BIL Funding

On May 31, 2023, NOAA announced the availability of approximately \$1.8 million for federally recognized tribes. This funding is provided under the Bipartisan Infrastructure Law. The focus is on encouraging increased tribal participation with regional ocean partnerships. EPA's Proposed Rule to Revise Clean Water Act Section 404 Tribal and State Program Regulations

Deadline: October 13, 2023

On July 19, 2023, the U.S. Environmental Protection Agency (EPA) announced a proposed rule to revise the Clean Water Act (CWA) Section 404 Tribal and State Program Regulations. The proposed regulatory revision will streamline and clarify the requirements and steps necessary for states and Tribes to administer programs protecting waterways from discharges of dredged or fill material without a permit. EPA's proposal would address key barriers identified by states and Tribes to administering CWA section 404 while expanding opportunities for Tribes to meaningfully engage in permitting actions.

EPA's Proposed Renewal of the forthcoming National Pollutant Discharge Elimination System (NPDES) Pesticide General Permit (PGP) under the Clean Water Act Deadline: October 27, 2023

EPA is initiating consultation and coordination with federally recognized tribes on the proposed renewal of the forthcoming National Pollutant Discharge Elimination System (NPDES) Pesticide General Permit (PGP) under the Clean Water Act (CWA). EPA renews this permit every five years, and the current PGP is scheduled to expire on October 31, 2026.

Tribal Consultation & Public Comment Opportunities (continued)

EPA's PGP regulates discharges of biological pesticides and chemical pesticides that leave a residue in waters of the United States. The PGP covers pesticide discharges from the following pesticide use patterns: (1) mosquito and other flying insect pest control, (2) weed and algae control, (3) animal pest control, and (4) forest canopy pest control. With limited exceptions, EPA directly implements the NPDES program in Indian country where tribes are not approved to administer the NPDES program.
