For the past twenty-two (22) years Mansel A. Nelson has served with the Institute for Tribal Environmental Professionals (ITEP) at Northern Arizona University. He is the Project Director for the Environmental Education Outreach Program (EEOP) and for the Indoor Air Quality in Tribal Communities (IAQTC). Prior to his service with Northern Arizona University, Mansel served in the US Army Chemical Corps for 14 years and taught chemistry on the Navajo Nation for 6 years. Mansel's formal education includes a BS in chemistry and a MS in Chemical Engineering. Through the EEOP Mansel helps youth understand how to apply science and engineering to local environmental issues and conducts internship programs. Through the IAQTC Mansel helps tribal staff develop healthy homes and healthy schools programs.

Billy Connor has over 50 years of experience in road design, construction and maintenance in Alaska. Much of that time was spent leading Alaska DOT&PF's Research including the development of the department's pavement design procedures, improvement of asphalt paved roads, and unpaved gravel roads and airports.
